## What is the Equal Business Opportunity Ordinance?

This ordinance provides equal opportunities for city contracting to UBEs owned by minorities or women and prohibits discrimination against any firm pursing contracting opportunities or conducting contracting activities, while correcting present effects of past discrimination.

# What are Underutilized Business Enterprises (UBEs)?

Is a business that is certified by the state (Department of Administration) and where at least fifty-one percent (51%) of the business is owned by one or more persons who are members of at least one of the following groups: Black, Hispanic, Asian American, American Indian, Female, Disabled, or Disadvantaged.
